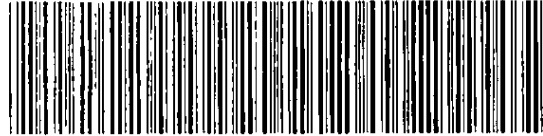


ARTICLE VIII


