## ARTICLES OF ORGANIZATION OF POR FORT PIERCE, LLC

1. <u>Name.</u> The name of this limited liability company is **POR FORT PIERCE**, LLC, a Florida limited liability company (the "<u>Company</u>"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.
