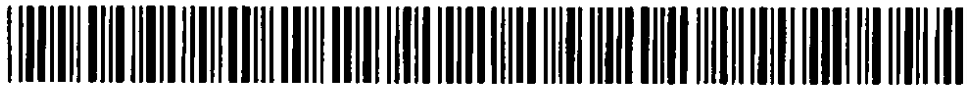


ARTICLE IX-TERMINATION OF EXISTENCE

ARTICLE X-INDEMNIFICATION


