AMENDED AND RESTATED
ARTICLES OF ORGANIZATION FOR
ALLORI, LLC

The original Articles of Organization for ALLORI, LLC were filed on May 24, 2022, and assigned Document Number L22000242093. Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, the undersigned Florida limited liability company hereby amends and restates its Articles of Organization in their entirety and adopts the following Amended and Restated Articles of Organization in their place:

ARTICLE I

Name

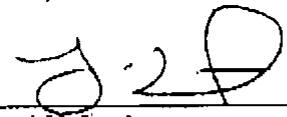
