**ARTICLES OF ORGANIZATION
OF

ARTICLE I - NAME

The name of the limited liability company is GIBSON LOTT PROPERTIES, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE V - REGISTERED OFFICE AND AGENT


