Pursuant to Section 605.0202 of the Florida Statutes, the Articles of Organization of Maniro Investment LLC (the "Company"), are hereby amended according to these Articles of Amendment:

**FIRST:** The name of the Company is **MANIRO INVESTMENT LLC**

**SECOND:** Article III of the Articles of Organization of the Company is amended in its entirety to read as follows:

**ARTICLE III

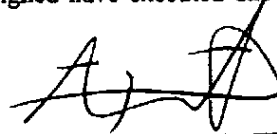
