**ARTICLES OF ORGANIZATION

The undersigned, a natural person competent to contract and an authorized representative of a member of OLD CROWE RANCH, LLC, hereby presents these Articles of Organization as the Articles of Organization of Old Crowe Ranch, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is OLD CROWE RANCH, LLC. This limited liability company is referred to in these Articles of Organization as the "**Company**."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE VI - MANAGEMENT




