**ARTICLES OF ORGANIZATION  
OF  
JNPAC, LLC**

The undersigned, for the purpose of forming a limited liability company under the laws of Florida, hereby adopts the following Articles of Organization:

**ARTICLE I**

**NAME**

The name of the limited liability company is **JNPAC, LLC.**

**ARTICLE II**

**ADDRESS**

Additional member(s) may be admitted upon the prior written approval of then existing members who own a majority of the interests in the company.

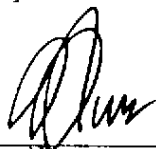
**ARTICLE VI**
