**ARTICLES OF ORGANIZATION

The undersigned, ELIZABETH WILLIAMS JASPERSON, competent to contract and an authorized representative of TUTU MANNER, LLC, hereby presents these Articles of Organization as the Articles of Organization of TUTU MANNER, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is TUTU MANNER, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS


