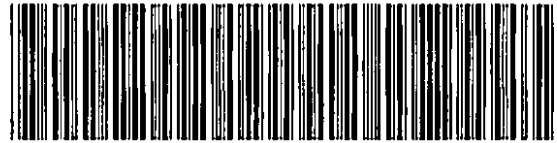

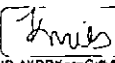

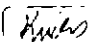

1. **Conversion.** Pursuant to the provisions of Section 14-2-1109.3 of the Georgia Business Corporation Code (the "Code"), KOLOURS BY KESH COSMETICS LLC, a Georgia limited liability company (the "Company") hereby elects to convert from a Georgia limited liability company to a foreign limited liability company, to be filed in the state of Florida as a limited liability company named KOLOURS BY KESH COSMETICS LLC.
