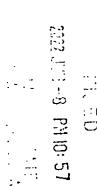

- Conversion. Pursuant to the provisions of Section 14-2-1109.3 of the Georgia Business
  Corporation Code (the "Code"), KOLOURS BY KESH COSMETICS LLC, a Georgia limited
  liability company (the "Company") hereby elects to convert from a Georgia limited liability
  company to a foreign limited liability company, to be filed in the state of Florida as a
  limited liability company named KOLOURS BY KESH COSMETICS LLC.
- 2. <u>Effective Date</u>. The effective date for this election shall be the date of its filing with the Georgia Secretary of State's Office.
- 3. <u>Approval</u>. This conversion has been unanimously approved by all of the members of the company's required by Section 14-2-1109.3(2) of the Code.
- 4. <u>Articles of Formation</u>. The Articles of formation cannot be obtained from the state of Florida until they have proof that the state of Georgia has approval this conversion.
