**ARTICLES OF ORGANIZATION  
OF  
TALOS TECHNOLOGY HOLDINGS, LLC**

The undersigned, being the sole member, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, do hereby adopt the following Articles of Organization:

**ARTICLE I  
NAME**

The name of the limited liability company is TALOS TECHNOLOGY HOLDINGS, LLC (the "Company").

**ARTICLE II  
ADDRESS**

The principal place of business and mailing address of the Company is:

**ARTICLE III  
REGISTERED AGENT AND OFFICE**
