6. The plan of conversion has been approved by the eligible converting entity in accordance with this chapter and the laws of its current/organic jurisdiction.

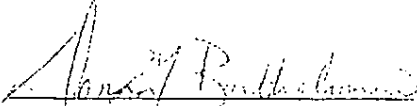

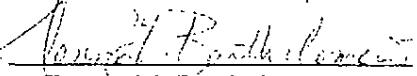
