ARTICLES OF ORGANIZATION OF VIRGILIO VENTURES, LLC

ARTICLE V OPERATING AGREEMENT

The power to adopt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the Members unless vested in the Manager of the Company by any amendments of the Articles of Organization. Each of the Members shall enter into an Operating Agreement for the Company containing such terms and conditions as are agreed upon by the Members.
