ARTICLES OF ORGANIZATION OF 30A TEA AT SRB, LLC

The undersigned, Nathan Gilliam, a natural person competent to contract and an authorized representative of 30A Tea at SRB, LLC, hereby presents these Articles of Organization as the Articles of Organization of 30A Tea at SRB, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is 30A Tea at SRB, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."
