ARTICLES OF ORGANIZATION OF 30A TEA HOLDINGS, LLC

The undersigned, Nathan Gilliam, a natural person competent to contract and an authorized representative of 30A Tea Holdings, LLC, hereby presents these Articles of Organization as the Articles of Organization of 30A Tea Holdings, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is 30A Tea Holdings, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the Company's initial principal office is 147 Log Landing Street, Inlet Beach, Florida 32461. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS
