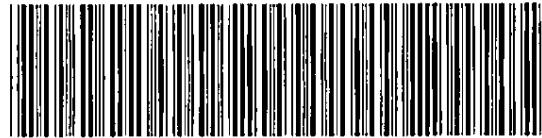

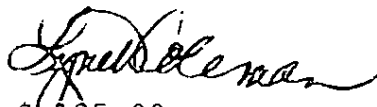

ARTICLES OF ORGANIZATION  
OF

The undersigned person, acting as the organizer of CRESCENT ROYAL AD, LLC, under the Florida Limited Liability Company Act, Chapter 605.0201, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME

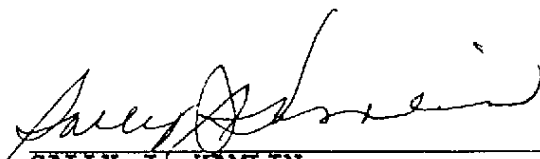
#### ARTICLE XI - TERMINATION OF MEMBERSHIP INTEREST

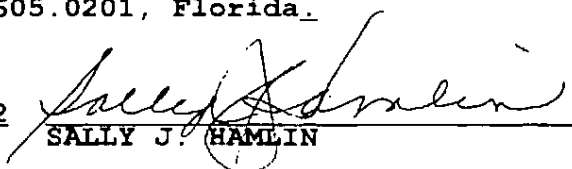
