**ARTICLES OF ORGANIZATION
OF
FRUITVILLE BREWING COMPANY, LLC**

1. Name. The name of this limited liability company is FRUITVILLE BREWING COMPANY, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Duration. The Company's existence shall be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Principal Office. The mailing and street address of the Company's principal office is 11294 Beebalm Circle, Lakewood Ranch, Florida 34202.




