**ARTICLES OF ORGANIZATION
OF
WOODARD MANAGEMENT, LLC**

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

**ARTICLE I
NAME**

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is WOODARD MANAGEMENT, LLC.

**ARTICLE II
ADDRESS**

The Company's street address of its principal place of business in Florida is 1513 Island Green Drive, Miramar Beach, Florida 32550, and its mailing address is the same, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the Manager.

**ARTICLE III
MANAGEMENT**

Any amendment to these Articles of Organization shall be on such form prescribed by the Florida Secretary of State, containing such terms and provisions consistent with Chapter 605 of the Florida Statutes, and approved by the Manager of the Company.
