

**ARTICLES OF ORGANIZATION FOR
G. SAULTER ENTERPRISES LLC**

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as the same may from time to time be amended (the "Act").

**ARTICLE I
NAME & ADDRESS OF PRINCIPAL PLACE OF BUSINESS**

The name of this limited liability company (the "Company") is G. Saulter Enterprises LLC. The mailing address and street address of the principal office for this Company is 1101 Lee Road, Apt. 48, Orlando, FL 32810.

**ARTICLE II
INITIAL REGISTERED OFFICE AND AGENT**


**ARTICLE III

Except as otherwise expressly provided by the Act, no member, manager, officer, agent or employee of the Company shall be personally liable for the debts, obligations or liabilities of the Company, whether arising in contract, tort or otherwise, or for the acts or omissions of any other member, manager, officer, agent or employee of the Company. The Company's nature and purpose is to operate in commerce for profit for any lawful purpose with an indefinite duration.
