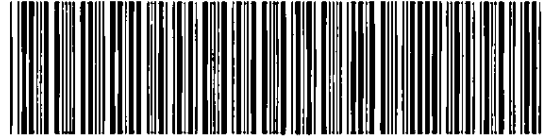

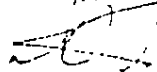
The undersigned is an officer and director of Florida International Bible College and Seminary, Inc., a Florida not for profit corporation ("Corporation") whose document number is N21000006512. The Corporation wants to form a Florida limited liability company using the same exact name as the Corporation.

The Corporation submitted articles of conversion along with articles of organization so that Corporation could change its structure to a LLC. However, the document was not filed and was returned on the basis that a Florida not for profit corporation cannot convert to a Florida limited liability company. 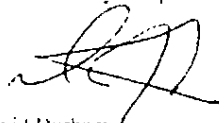
