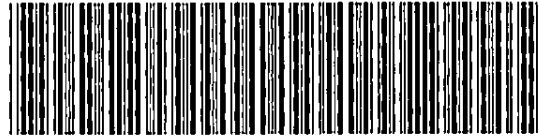



OTHER PROVISIONS


