ARTICLES OF ORGANIZATION**OF****TB METRO HOLDINGS, LLC**

1. Name. The name of this limited liability company is **TB METRO HOLDINGS, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida (the "Act").

2. Duration and Effective Date. The Company's existence shall be perpetual, and the effective date of commencement of the Company's existence shall be July 5, 2022.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
