ARTICLES OF ORGANIZATION

OF

2157 RIVER PARK, LLC

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

ARTICLE I NAME

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is 2157 RIVER PARK, LLC.

ARTICLE II ADDRESS

The Company's street address of its principal place of business in Florida is 1320 E Jordan Street, Pensacola, Florida 32503 its mailing address is 1320 E Jordan Street, Pensacola, Florida 32503, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the Manager.

ARTICLE III MANAGEMENT,

New members may only be admitted as provided in the Operating Agreement of the Company. A member's interest in the Company may only be sold or transferred as proxided in the Operating Agreement of the Company.

ARTICLE V AMENDMENT TO ARTICLES

Any amendment to these Articles of Organization shall be on such form prescribed by the Florida Secretary of State, containing such terms and provisions consistent with Chapter 605 of the Florida Statutes, and approved by the Manager of the Company.
