**ARTICLES OF ORGANIZATION
OF

Fife III, a natural person competent to contract and an authorized representative of Outpost RV, LLC, hereby presents these Articles of Organization as the Articles of Organization of Outpost RV, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Outpost RV, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the Company's initial principal office is 92 Banfill Street, Santa Rosa Beach, Florida 32459. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE VI - MANAGEMENT


The Company shall be managed by a manager in accordance with the terms of the Operating Agreement of the Company. The name and address of the initial manager of the Company is as follows:


