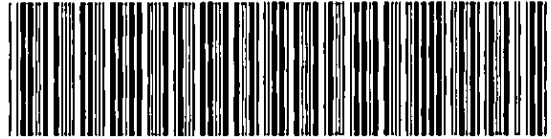



No member of the Company shall be an agent of the Company solely by virtue of being a member.

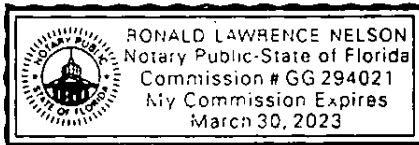

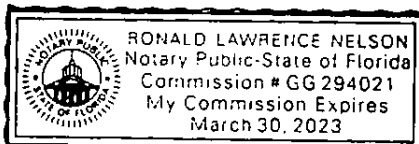
