These Articles of Merger are submitted in accordance with the Florida Revised Limited Liability Company Act (the "Act"), pursuant to Section 605.1025, Florida Statutes.

FIRST: The exact name, entity type, and jurisdiction of the merging entity is as follows:

CTG ENTERPRISES, LLC, a Connecticut limited liability company (the "Merging Company"); and

SECOND: The exact name, entity type, and jurisdiction of the surviving entity is as follows:

GLIMPSE ADVISORY LLC, a Florida limited liability company (the "Surviving Company").

THIRD: The plan of merger (the "Plan of Merger") has been approved and adopted by the Merging Company and the Surviving Company, in accordance with the Act and the Connecticut Business Corporation Act.

FOURTH: The Merger is permitted by the laws of the State of Connecticut, the domestic jurisdiction of the Merging Company, and was unanimously approved by joint written consent of the managers and members of the Merging Company, pursuant to Section 34-279i of the Connecticut Uniform Limited Liability Company Act, dated as of August 11, 2022.

FIFTH: The merger is permitted by the laws of the State of Florida, the domestic jurisdiction of the Surviving Company, and was unanimously approved by joint written consent of the managers and members of the Surviving Corporation, pursuant to Sections 605.04073 and 605.1023 of the Florida Revised Limited Liability Company Act, dated as of August 11, 2022.

SIXTH: This entity agrees to pay any members with appraisal rights the amount, to which members are entitled under ss.605.1006 and 605.1061-605.1072, F.S.


SEVENTH: The effective date and time of the Merger shall be upon filing of the Articles of Merger with the Secretary of State of Florida.


