ARTICLES OF ORGANIZATION OF NASHVILLE RIVERBOATS, LLC

The undersigned authorized representative does hereby certify that the persons so identified herein have associated themselves together for the purpose of forming a limited liability company (the "Company") under the laws of the State of Florida.

ARTICLE I NAME

The name of the Company shall be: NASHVILLE RIVERBOATS, LLC.

ARTICLE II ADDRESS AND PLACE OF BUSINESS

ARTICLE III EFFECTIVE DATE; PERIOD OF DURATION

The effective date shall be July 11, 2022. The period of duration of the Company shall be perpetual.

ARTICLE IV GENERAL POWERS

The Company shall have the power to conduct and undertake, any and all other business purposes, activities and actions authorized under the Florida Revised Limited Liability Company Act. Chapter 605, Florida Statutes.

ARTICLE V MANAGEMENT

All powers of the Company shall be exercised by or under the authority of the manager and, except as otherwise provided in the operating agreement of the Company, if any ("Operating Agreement"), the business and affairs of the Company shall be managed by or under the direction of the manager. The initial Manager of the Company shall be Troy M. Manthey, whose mailing address is 3611 West Sevilla Street, Tampa, FL 33629.

ARTICLE VI OPERATING AGREEMENT

The members of the Company may adopt an operating agreement pertaining to the regulation, management, and other affairs of the Company (previously defined as the "Operating Agreement"), provided that such Operating Agreement shall not be inconsistent with these Articles of Organization or with the laws of the State of Florida. The Operating Agreement may be repealed or altered only in the manner now or hereafter prescribed therein, consistent with the laws of the State of Florida.

ARTICLE VII REGISTERED OFFICE AND REGISTERED AGENT

The street address of the Company's initial registered office in Florida is 410 East Jackson Street, Suite 3100, Tampa, FL 33602, and the name of its initial registered agent is Chestnut Business Services, LLC. The Company may change its registered office or its registered agent or both by filing with the Department of State of the State of Florida a statement complying with Section 608.416, Florida Statutes.

ARTICLE VIII ACKNOWLEDGMENT

The members of the Company, through their undersigned authorized representative, do hereby certify that the foregoing constitutes the proposed Articles of Organization of NASHVILLE RIVERBOATS, LLC. The Articles of Organization may be amended from time to time by consent of the members holding a majority of the voting interests of the Company, or otherwise in the manner now or hereafter prescribed in the Company's Operating Agreement, consistent with the laws of the State of Florida.
