The period of duration for the Company shall be perpetual, unless dissolved in accordance with the terms of the Operating Agreement of the Company.

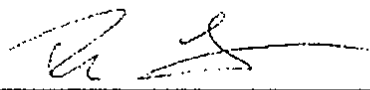
ARTICLE IV: MANAGEMENT

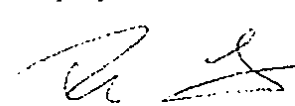
