# ARTICLES OF ORGANIZATION OF MAK-ORMOND, LLC

#### SECTION 1 INTRODUCTION AND PRELIMINARY STATEMENTS

This Operating Agreement may be amended from time to time according to its provisions.

#### SECTION 12 MANAGEMENT
