ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be: **BUGANVILLA HOUSE, LLC**, a Florida limited liability company (hereinafter "the Company").

ARTICLE II -- ADDRESS

The Company shall commence its existence on the date these Articles Of Organization are filed by the Florida Department Of State. The Company's existence shall be perpetual, unless the Company is dissolved earlier as provided in these Articles Of Organization or in any Operating Agreement of the Company.

Except as set forth in any Operating Agreement of the Company, no additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on the terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in any Operating Agreement of the Company, but the transferee shall have no right to participate or vote in the management of the business and affairs of the Company or become a member unless all of the members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by prior written consent.

ARTICLE VI -- MEMBERS' RIGHT TO CONTINUE BUSINESS



ARTICLE VII -- MANAGEMENT

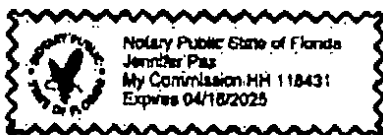
