**Articles of Organization  
of  
Madden Law, PLLC**

The undersigned, Christopher Madden, a natural person licensed to practice law in Florida and the sole member of Christopher Madden, PLLC, which is a member of this professional limited liability company, hereby presents these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapter 621, Florida Statutes.

**Article 1 - Name**

The name of the professional limited liability company (hereinafter the "Professional Limited Liability Company") is Madden Law, PLLC.

**Article 2 - Address**

The mailing address and the street address of the principal office of the Professional Limited Liability Company are: 52 Cambium Court, Inlet Beach, Florida 32461.

**Article 3 - Purpose and Powers**

The Professional Limited Liability Company is organized for the purpose of providing professional legal services for any legal and lawful purpose for which a professional limited liability company may be organized and may exercise all powers and rights which a professional limited liability company may exercise under the Professional Service Corporation and Limited Liability Company Act.

**Article 4 - Members**

Individual members must be licensed to practice law in the State of Florida. The shareholders of any member that is a professional service corporation and the members of any member that is a professional limited liability company must each be licensed to practice law in the State of Florida. Contributions required of new members shall be determined as of the time of admission to the professional limited liability company in accordance with its operating agreement.

A member's interest in the Professional Limited Liability Company may not be sold or otherwise transferred except to a person licensed to practice law in the State of Florida, in accordance with the operating agreement of the Professional Limited Liability Company.

**Article 5 - Duration**

The period of duration of the Professional Limited Liability Company shall be perpetual.

**Article 6 - Management**

The Professional Limited Liability Company is to be managed by its sole member. The name and addresses of the member of the professional limited liability company are: Christopher Madden, PLLC, 52 Cambium Court, Inlet Beach, Florida 32461.


**Article 7 - Registered Agent**

**Article 8 - Time of Formation**


