**A Florida Limited Liability Company**

**FIRST:** The name of the Limited Liability Company shall be 2919 24TH STREET WEST, LLC (hereinafter referred to as the "Company").

**SECOND:** The mailing address and street address of the principal office of the Limited Liability Company is 3425 Yawkey Avenue, Sarasota, Florida 34232.

**THIRD:** The duration of the Company's existence shall be perpetual.

**FOURTH:** The purposes for which the Company is organized are any and all lawful purposes for which a Limited Liability Company may be organized pursuant to the laws of the State of Florida and the United States.

**FIFTH:** The Company shall be managed by its Sole Manager. Initially, there shall be ONE (1) Manager whose name and address is Julie Kaiyoorawongs, 3425 Yawkey Avenue, Sarasota, Florida, 34232.

**SIXTH:** The Company shall be initially authorized and empowered to issue one class of Membership Unit.

**SEVENTH:** By majority vote of authorized and outstanding Membership Units, the Members may agree to admit additional Members to join the Company and establish the terms of their contributions to join.

**EIGHTH:** In the event of the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, or the occurrence of any other event which terminates the continued membership of a Member in the Company, the remaining Members, or the legal representative of the last Member, may continue the business thereof.


**NINTH:** Whenever a Member or his/her legal representative requests a step-up election under Section 754 of the Internal Revenue Code as the same may be amended from time to time, such election shall be made as all Members of the Limited Liability Company, upon subscription for units therein, hereby irrevocably consent to such election when requested by any other Member.

**TENTH:** Whenever income is earned by the Company, there shall be, at a minimum, sufficient distribution of income to its Members to allow them to pay, on a timely basis, all of their U.S. Federal, State and local tax liabilities imposed by virtue of their membership interest in the Company.




