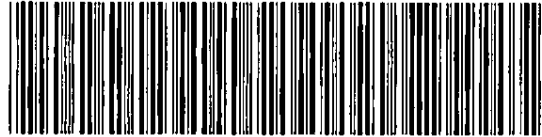

THIS ASSIGNMENT AND ASSUMPTION OF MEMBERSHIP INTERESTS (this "Assignment") is dated as of September 18, 2023, among Julio Pagan, Matthew A. Pagan, Michael Pagan and McCord Pagan ("Assignors") and Blue Harvest Moon, LLC, a Holding company LLC formed under the laws of Wyoming (the "Assignee"), recites, and provides as follows:

RECITALS:

WHEREAS, the Assignors are the owners of an aggregate 100 percent (100%) Membership Interest in Vero Beach Home Solutions, LLC, a limited liability company (the "Company"); and

The Assignors now wish to assign and transfer to the Assignee all of the Assignor's rights, title and interest in and to the Assigned Interest.

ASSIGNMENT AND ASSUMPTION AGREEMENT:

For and in consideration of the sum of Ten Dollars (\$10.00), and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignment. The Assignors hereby sells, conveys, assigns and transfers to the Assignee all of the Assignor's rights, title and interests in and to the Assigned Interest subject to the terms and conditions of that certain Operating Agreement of the Company dated July 18, 2022 (the "Operating Agreement").


2. Acceptance, Assumption and Indemnity by Assignee.
