**ARTICLES OF ORGANIZATION
OF

The undersigned, Scott A. Remington, competent to contract and an authorized representative of WHITESELL FAMILY HOLDINGS, LLC, hereby presents these Articles of Organization as the Articles of Organization of WHITESELL FAMILY HOLDINGS, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is WHITESELL FAMILY HOLDINGS, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS


