# ARTICLES OF ORGANIZATION OF ADVENIR MOB@CINCINNATI, LLC

The undersigned, for the purpose of forming a limited liability company under the Borida Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes. thereby makes, acknowledges and files the following Articles of Organization (the "Articles").

#### ARTICLE I NAME

The name of the limited liability company is Advenir MOB@Cincinnati, LLC (the "Company").

#### ARTICLE II MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 17501 Biscavne Boulevard, Suite 300, Aventura, Florida 33160.

#### ARTICLE III REGISTERED AGENT AND OFFICE

The Articles may be amended only in accordance with the Operating Agreement.
