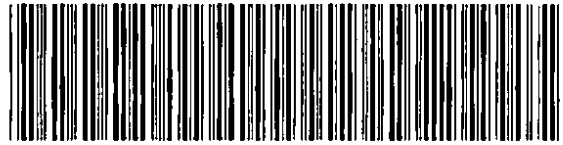

ARTICLES OF ORGANIZATION

ARTICLE I
NAME




