




SALE AND ASSIGNMENT OF MEMBERSHIP INTEREST IN RIVERSTONE APARTMENTS, LLC

WHEREAS, RIVERSTONE APARTMENTS, LLC (the "Company") is a duly formed and existing limited liability company under the laws of the State of Florida; and

WHEREAS, there presently exists two (2) Members of the Company, namely, Steven W. Corbett ("Corbett") and Juston Trimback ("Trimback"); and

WHEREAS, Corbett desires to sell, transfer and convey Corbett's 50% membership interest in the Company, the same being all of Corbett's membership interest in the Company ("Corbett's Membership Interest"), to Trimback.

NOW THEREFORE, in consideration of or \$10.00 in hand paid to Corbett by Trimback, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. Corbett hereby irrevocably transfers, assigns and conveys to Trimback all of Corbett's Membership Interest.
- 2. Following this Assignment, the Ownership Percentage or Percentage Interest in the Company will be owned as follows:

Corbett hereby warrants, represents, covenants and agrees that Corbett is lawfully seized and possessed of Corbett's Membership Interest, that Corbett has good right to sell or transfer the same to Trimback, and Corbett sells or transfers Corbett's Membership Interest free and clear of any and all liens and encumbrances.
- 4. The Company and Trimback agree to indemnify and hold Corbett harmless from any and all debts, liabilities and obligations of the Company.
- 5. All parties hereto waive the requirement of any opinion of legal counsel as to the exemption of this transaction under federal and state securities laws.
- 6. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective heirs, administrators, executors and assigns.
- 7. This Assignment shall be construed and interpreted under the laws of the State of Florida.
