**ARTICLES OF ORGANIZATION

The undersigned, R. Wayne Sumlin, a natural person competent to contract and a member of Moss Farm LLC, hereby presents these Articles of Organization as the Articles of Organization of Moss Farm LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Moss Farm LLC. This limited liability company is referred to in these Articles of Organization as the "**Company**."

ARTICLE II - PRINCIPAL OFFICE ADDRESS




