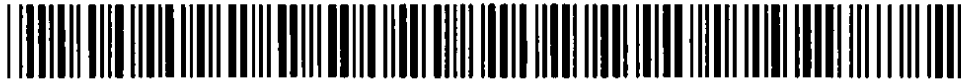

ARTICLE 1


