**ARTICLES OF ORGANIZATION  
OF

1. Name. The name of this limited liability company is **RRVH LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Place of Principal Office. The mailing and street address of the Company's principal office is **5118 West Poe Avenue, Tampa, Florida 33629.**
