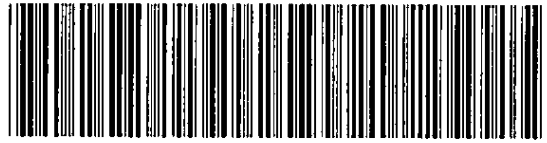

**ARTICLES OF ORGANIZATION
OF

A Florida Limited Liability Company

The undersigned individual, acting in his capacity as organizer of 274 FANTASY LLC as contemplated by the Florida Revised Limited Liability Company Act, Chapter 605, Fla. Stat., adopts the following Articles of Organization:

ARTICLE I – NAME
