ARTICLES OF ORGANIZATION FOR GEN H. ENTERPRISES, L.L.C.

The undersigned hereby forms a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, and adopt as the Articles of Organization of such limited liability company the following:

X. <u>Annual Meetings:</u>

All regularly scheduled annual meetings may be held only following twenty (20) day notice of meeting providing the date, time, place and purpose of the meeting, whiless waived by all members.

XI. Special Meetings:

All special meetings of the Managers must be preceded by at least a seven (7) day notice of the date, time, place and purpose of the special meeting, unless waived by all members.

XII. Amendments to Articles:

Managers may adopt amendments to the Company Articles of Organization or to the Operating Agreement without member consent as necessary; however the unanimous consent of all Managers is required to amend either of those documents.

XIII.

Dissolution of Company:

A proposal by management to dissolve the Company must be voted on by the members.

XIV. Managers' Compensation:

Managers will not receive compensation; however, they shall be reimbursed for all reasonable expenses advanced on behalf of the Company.

XV. Other provisions for the regulation of the internal affairs of the limited liability company:

- (1) The Company shall indemnify an individual made a party to a proceeding because he/she is or was a member, manager, officer, employee or agent of the Company against liability incurred in the proceeding if:
 - They conducted themselves in good faith; and (a)
 - They reasonably believed that their conduct was in or at least not opposed to the Company's best interest; and
 - (c) In the case of any criminal proceeding they had no reasonable cause to believe his/her conduct was unlawful.
- (2) The Company shall pay for or reimburse the reasonable expenses incurred by a member, manager, officer, employee or agent of the Company who is a party to a proceeding in advance of final disposition of the proceeding if:
 - the individual furnishes the Company a written affirmation of his good faith belief that they have met the standard of conduct described herein;
 - the individual furnishes the Company a written undertaking executed personally or on his/her behalf to repay the advance if it is ultimately determined that they did not meet the standard of conduct; and
 - (c) a determination is made that the facts then known to those making the determination would not preclude indemnification under the law.
- (3)The indemnification and advance of expenses authorized herein shall not

employee or agent may be entitled under any By-law, regulation. agreement, vote of members or disinterested managers or otherwise. The Articles of Organization shall not be interpreted to limit in any manner the indemnification or right to advancement for expenses of an individual who would otherwise be entitled thereto.
