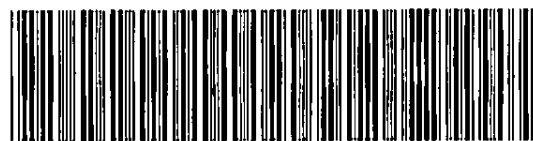

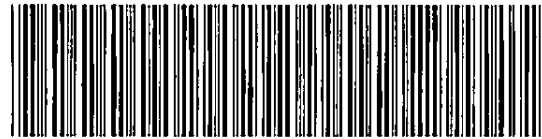

Articles of Dissolution
of

Pursuant to F.S.S. 617.1402 and 617.1403 of the Florida Statutes, Lake Park Baptist School, Inc., a Florida not-for-profit corporation, hereinafter (the "**Corporation**"), submits the following Articles of Dissolution:

1. The name of the Corporation is Lake Park Baptist School, Inc.; and
2. The effective date of dissolution is the 31st day of May 2024, and
3. The Corporation has no members entitled to vote on the dissolution of the Corporation.
4. The Corporation has four (4) directors, and the dissolution was approved by a resolution of the Board of Directors on the 26 day of APRIL 2024. The vote for the resolution was four (4) for and zero (-0-) against, and
5. That all liabilities and obligations of the Corporation have been paid or discharged or that the officers of the Corporation have made adequate provision to pay or discharge the liabilities and obligations of the Corporation; and
6. That all remaining property and assets of the Corporation have or will be distributed to First Baptist Church of West Palm Beach, Florida, a Florida not-for-profit corporation and 501(c)(3) organization in accordance with the provisions of the Corporation's Articles of Incorporation; and
7. No actions are pending against the Corporation in any court, and adequate provision has been made to satisfy any judgment, order, or decree that may be entered against it in any pending action.
