**Articles Of Organization
Of
PARROTT INVESTMENT PROPERTY I, LLC**

**Article I
Name**

The name of the limited liability company ("Company") is **PARROTT INVESTMENT PROPERTY I, LLC**.

**Article II
Address**

The mailing and street address of the Company's principal office is 21835 Lake Seneca Road, Eustis, FL 32736.

**Article III
Duration**

The period of duration for the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.

**Article IV
Purpose and Powers**

This Company is organized with a general business purpose, and has all powers provided by law and may use those powers to any lawful purpose.

**Article V
Registered Agent and Office**

The name of the Company's initial registered agent in Florida is Zachary T. Broome, Esq., Bowen & Schroth, P.A. The address of the Company's registered office in Florida is 600 Jennings Ave., Eustis, Florida 32726.

**Article VI
Management**

The Company will be managed by a Manager, as further provided in the Company's Operating Agreement. The initial manager(s), who shall serve until the earlier of their deaths, resignations, replacements or until the first annual meeting of members and their successors are elected and qualified, shall be: **LINDA PARROTT and NICHOLAS PARROTT**.

**Article VII
Admission of New Members**



Members of the Company have the right to admit new members. Members may admit to the Company additional members to participate in the profits, losses, available cash flow, and ownership of the assets of the Company on such terms as are determined by all of the members. Admission of any such additional members requires the written consent of all members then having any ownership interest in the Company. Any additional members are allocated gain, loss, income or expense by the method provided in the Operating Agreement of the Company, and if no method is specified, then as may be permitted by the Internal Revenue Code of 1986, as amended.

Article VIII Continuation of Business

The business may be continued only on the unanimous consent of the remaining members.


