**Article I  
Name**

The name of the limited liability company ("Company") is **PARROTT INVESTMENT PROPERTY I, LLC**.

**Article II  
Address**

The mailing and street address of the Company's principal office is 21835 Lake Seneca Road, Eustis, FL. 32736.

Duration**


