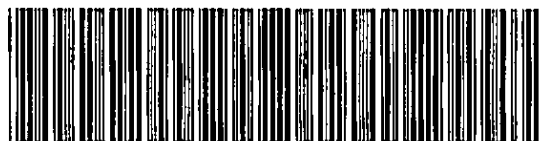

**ARTICLE I  
NAME**

The name of this Limited Liability Company shall be: **CLASSY ELEGANCE LLC.**
