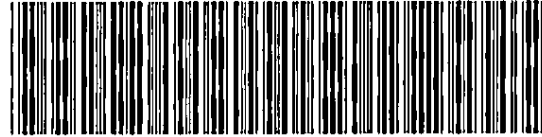

**ARTICLES OF ORGANIZATION OF
148 MARINA PLAZA RESTAURANT LLC**

The undersigned, acting as the authorized representative of 148 Marina Plaza Restaurant LLC (the "Company"), does hereby certify that said member has formed the Company to be a limited liability company under the laws of the State of Florida and under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as amended (the "Act"), and, pursuant to the Act, hereby sets forth the following Articles of Organization:

ARTICLE I: NAME

The name of the Company shall be 148 Marina Plaza Restaurant LLC.

ARTICLE II: ADDRESS AND PLACE OF BUSINESS

The initial address of the principal office and the mailing address of the Company shall be 401 Gulf Blvd, Indian Rocks Beach, Florida 33785.

ARTICLE III: DURATION AND PURPOSE

The period of duration of the Company shall be perpetual. The Company is formed for the purpose of conducting and undertaking, and shall have the power to conduct and undertake, any and all activities and actions authorized under the Act.

ARTICLE IV: MANAGEMENT

The Company shall be manager-managed and all powers of the Company shall be exercised by or under the authority of the manager except as otherwise provided in the operating agreement of the Company. The initial manager shall be Big Claw Management, LLC.

ARTICLE V: REGISTERED OFFICE AND REGISTERED AGENT


