## RE: ARTICLES OF REVOCATION OF DISSOLUTION CADILab Pilates, LLC L22000357765

I hereby file to revoke the dissolution of CADiLab Pilates, LLC.

I was recently shocked to learn that Barbara Crean filed Articles of Dissolution on April 28, 2023, online with Department of State. This action was illegal and fraudulently completed by Ms. Crean without my consent, which is contrary to Florida Statute Sec. 605.0707, as well as our operating agreement.

Per Florida Statute Section 605.0701, "a limited liability company is dissolved, and its activities and affairs must be wound up upon the occurrence of the following:

- (1) An event or circumstance that the operating agreement states causes dissolution.
  - (2) The consent of all the members.

Our operating agreement merely states that both members of CADiLab Pilates, LLC must agree before dissolution can occur. I am a 50% owner and member of CADiLab Pilates, LCC, and the Managing Member.

Barbara Crean e-signed the Articles of Dissolution asserting that her filing complied with section 605.0701, and indicating to the Department of State that she had my consent. Barbara Crean signed the Articles of Dissolution stating, "I/we submit this document and affirm that the facts stated herein are true. I/we am/are aware that any false information submitted in a document to the Department of State constitutes a third-degree felony as provided for in section 817.155, Florida Statutes."

This was not true. She not only did not have my consent, but I was totally unaware that she dissolved CADiLab Pilates, LLC, only days before our operating permits were issued by the City of Miami and after I personally invested more than \$150,000 in this company. Due to her actions, not only is our company unable to open and begin

operating in order to meet CADiLab's preexisting financial obligations, but our insurance is no longer valid, and the issuance of CADiLab's operating permits will be significantly delayed even if the dissolution is revoked immediately.

She was fully aware at the time of filing the Articles of Dissolution that she did not have my consent to dissolve the company. (Aside to this dissolution, Barbara Crean has committed several similar acts in an attempt to stop CADiLab from opening, including closing the bank account and taking the funds for her own personal use, informing clients that the studio would never open and telling them to request refunds, deleting the CADiLab instagram account, deleting the Yelp profile, and entering the facility during a marketing event in an effort to harass the new teacher in training and harass the front desk staff in training, which caused the police to be called.)

Barbara Crean's fraudulent action has caused me and CADiLab Pilates substantial financial harm. She took these actions without notifying me, her business partner, despite that she apparently designated me as the person to wind up company affairs. I only discovered recently that the company was dissolved when I looked up the company registration on Sunbiz in an effort to quickly find the EIN for other company business.

Ms. Crean had no power to dissolve this company without my knowledge and authorization.

Today I submit Articles of Revocation of Dissolution. Please process this request as soon as possible, and reinstate the company, so that CADiLab Pilates may fulfill its financial obligations.

I, Melissa A. McNamee, the Manager am now the only person authorized to make amendments to CADIiLab Pilates, LLC
