

MANAGEMENT

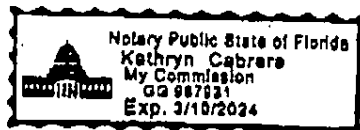




